## Question: 1

Officers Regina Petty and Thomas Fritz responded to a call about a loud party in progress at 5792 Windmere Avenue. Arriving at the house at approximately 1 AM, they heard loud rap music blaring from the house as soon as they exited their car. A couple dozen people were outside the house, spread out in the yard, on the porch, and on the sidewalk. As they approached the house, a man came out of the house next door and stopped the officers. He said "these people have been nothing but trouble since they moved in a year ago", and it was high time the police cracked down on them. According to the neighbor, within the last six months, police officers had been to the house to investigate public intoxication, another time for a domestic dispute call, a few weeks later for loud music, then again for cars parking illegally and impeding traffic, and the last time for a person who was drunk and disorderly. The officers said they were aware of the recent history of the occupants, and asked the neighbor to go back inside his house. They then approached the party house and asked for the homeowner. When he came to the door, the officers told him to end the party and send everyone home, or everyone there would be charged with disturbing the peace. The homeowner briefly argued with the officers, but then complied with their instructions. According to the neighbor, how many times had the police been to the house in the last six months?

- A. Five

According to the neighbor, within the last six months, police officers had been to the house to investigate (1) public intoxication, (2) another time for a domestic dispute call, (3) a few weeks later for loud music, (4) then again for cars parking illegally and impeding traffic, and (5) the last time for a person who was drunk and disorderly.

## Question: 2

Police are searching for a driver who fled from a car after a chase by several officers Tuesday night. At 9:21 p.m., Officer James Logan attempted to stop a vehicle for speeding on Grosvenor Drive. According to Officer Logan, the driver failed to yield and sped off heading south on Grosvenor, then turning east onto Eldridge Avenue. After nearly causing a collision with another car at the intersection of Scranton Street, he turned north onto Huddleston Pike and appeared to be heading for the freeway. He managed to elude the pursuing officers for only a short time, however, as he lost control of the car when he tried to cut through a parking lot and one of the tires blew out after jumping the curb. The driver fled the scene on foot and has not yet been caught, but he has been identified, according to the report. It was

soon discovered that the vehicle had been stolen at approximately 9:15 p.m. Where did the driver nearly collide with another car?

- A. The onramp of the freeway
- B. Cutting through a parking lot

### Question: 3

At approximately 7:00 pm,, Officer John Ramirez and Officer Bettina Woolsey were dispatched to a report of a fight taking place in the 1500 block of Maple Avenue. The caller stated that the males in the house had begun arguing over a football game on TV, which led to a physical altercation, and that one of her sons was unconscious and her nephew was bleeding. When the officers arrived, the woman answered the door and let them in the house, where they found four males who had obviously been fighting. Steven Jones, the woman's husband and the owner of the house, had a torn shirt and a lump on his forehead. His brother, Eric Jones, looked disheveled but didn't have any obvious injuries. Both men appeared to be between 40 and 50 years of age. Mark Jones, the son of Steven Jones and the female caller, and an occupant of the house, was lying on the couch and appeared to be woozy. Ethan Jones, the son of Eric Jones, had a makeshift bandage around his head, which was stained with blood. These two men were in their early twenties. None of the men were very cooperative with the officers. The female who called police said that her son and his cousin were watching a football game when her husband and brother-in-law demanded that they change the station so they could watch a different game. The younger men refused, and that's what started the fight. She said alcohol was also a factor. However, all of the men denied that they needed medical help, and they all refused to press charges, so the officers gave them a stern warning and departed without making any arrests. Who had a bloody forehead?

### Question: 4

After a series of mass brawls in the TV room of the main unit, prison officials decided to crack down on known or suspected members of prison gangs, by moving them to another unit, or transferring them to another prison. Six members of the Latin Kings were moved to other units, while three were transferred. Four members of the Outlaws were moved to other units, while two were transferred. Four members of the Gangster Disciples were moved to other units, while six were transferred. Seven members of the Mexican Mafia were moved to other units, while two were transferred. After these changes, violence in the main unit decreased substantially, while violence in the other units did not increase. Which prison gang saw the most members moved out of the unit or transferred?

### Question: 5

At approximately 9:30 p.m. on Wednesday, several officers were dispatched to the Bent Tree Gardens apartment complex at the intersection of Bent Tree Road and 14th Avenue, in response to calls about a large group of people fighting. Callers said the group had been arguing and screaming at each other for nearly two hours, and were on the verge of brawling. Upon arrival from a side alley, officers counted ten men and eight women in the brightly lit parking lot, divided into groups facing each other, and heard many of them exchanging threats of violence. When the crowd realized police had arrived, they took off running in various directions. All escaped except for two women, who were arrested and transported downtown for processing. Shortly after midnight, 911 callers reported that the group was back in the parking lot, again disturbing the peace and threatening to fight. This time, a larger number of officers responded, and while many of the brawlers successfully fled on foot, officers were able to detain five men and three women. One of the men and of the women were determined to be bystanders, and let go, but the rest were arrested and taken in for booking. How many women were arrested?

Three. The first-time officers went to the scene, they apprehended two women, who were arrested. The second time, they detained five men and three women. Of the women, two were let go, and one was arrested. Added to the two arrested previously, that makes a total of three women arrested.

### Question: 6

On Tuesday, 09/22, at approximately 4:11 a.m., a call for service was received about a rollover car accident in the area of Greenhills Blvd. and Robertson Rd. When they arrived on the scene, officers located a single vehicle on the sidewalk on the south side of the eastbound lanes of Greenhills Blvd., just west of Robertson Rd. That vehicle, a Toyota Corolla, had left the roadway and rolled over, landing on its roof, ejecting two female occupants and trapping two additional male occupants. All occupants were transported by ambulance to area hospitals. The driver, who was identified as 26-year-old Caitlyn Malcolm, was evaluated and arrested for DUI and Vehicular Assault. The 22-year-old female passenger, Britney Maddox, is currently being treated for serious injuries. The 26-year-old and 29-year-old male passengers, Ryan Telling and Rob Telling, were treated for less serious injuries and discharged from the hospital. The eastbound lanes of Greenhills Blvd. were temporarily closed to facilitate the investigation. The Major Accidents Unit responded to conduct the investigation in conjunction with the originally responding patrol officers. Who was charged with Vehicular Assault?

On Friday night they made three arrests for selling drugs, five for loitering, six for public intoxication, and nine for outstanding warrants. On Saturday afternoon, they made two arrests for selling drugs, nine for loitering and five for outstanding warrants. On Saturday night and into early Sunday morning, they arrested fifteen people for outstanding warrants, seven for selling drugs, ten for loitering, and six for public intoxication. Police officials said the crackdown will continue until the neighborhood sees a significant reduction in the crime rate. Altogether, how many people were arrested for selling drugs during the crackdown?
